#### A Software Engineer<sup>1</sup> And The Law

- I am 62+
- I have no phone
- I have no valid driver's license
- I no longer have a stable physical address
- I have been completely isolated and under an implied strict "house arrest" for years
- The courts have allowed my "forced indigency" (i.e., no assets, no savings, no car, etc.) for costs
- As per a 1/12/2022 court order, I must apply to 10 full-time jobs per week with Mass. employers

#### A Fabricated Family Tragedy<sup>2</sup>

- I am an involuntarily divorced father, and I have attempted to rebuild a new family after the divorce
- I have known about the "win-win" strategy directly from the "Father" of our "progressive" divorce laws
- The recipe is simple: provoke "evil" fathers to resist any inherently child-abusive treatment, and the reinterpreted "attacks" on protected "victim" mothers become justified causes for swift punishments

### A Defendant's Layman Efforts<sup>3</sup>
